- a. TEDI tree management – Scott Bowers has been caring for the trees by watering and weeding. Our survival rate has been great, approximately 90%. There are several trees that were planted by Delmarva that will need new stakes and netting this spring. We will be partnering with Ardentown to treat some areas that have invasive weeds with a pre-emergent weed spray that inhibits invasive seed germination while allowing other natives to grow unharmed. We are working with Weeds, inc. to minimize environmental impacts.
- b. Vegetation inventory – complete, app available for adding Beech Trees. Demo of the ESRI system TBD.
